REFORMING GOVERNMENT

Cracking Down on Child Labor Law Violations

I am the prime sponsor of legislation that would strengthen Pennsylvania's Child Labor Act to provide stronger penalties for unscrupulous employers who take advantage of the most vulnerable children. House Bill 1714 would also provide cross reporting requirements that will notify other appropriate authorities to protect the child in specific situations, including cases of unaccompanied minors.

The number of child labor violations nationwide has jumped dramatically in recent years and it's time we do something about it. Our state laws should be strengthened to better protect any at-risk child in the workplace and more harshly punish employers who take advantage of them.

Under my proposal, a violation of the act would be a second-degree misdemeanor if the violation was willful, and the employer knew or should have known the child was without proper parental supervision and took advantage of the situation.



Making Daylight Saving Time Permanent in Pennsylvania

It happens twice every year in most states, including Pennsylvania. We all make the switch between Daylight Saving Time and Standard Time, adding unnecessary stress to our lives.

I believe ending the practice of changing our clocks biannually is long overdue and have reintroduced legislation in the House that would make Daylight Saving Time permanent in the Commonwealth. Congress would first have to give states the authority to do so because it is currently against federal law.

The arguments in support of making the change to the same time year-round are numerous. Experts say more daylight in the evening could improve public safety, increase social and commercial activity, and lower electricity use.

A 2019 poll by the Associated Press also found that 70% of Americans want to end twice-a-year clock changes, with permanent Daylight Saving Time being the more popular option.

In recent years, about 30 states have introduced legislation to end the twice-yearly changing of clocks.

My proposal, House Bill 272, is currently under consideration by the House State Government Committee.

During House sessions, I often rise to debate the merits of legislation under consideration.

Combating Deepfake Sexual Exploitation

I have introduced legislation to help combat deepfake porn, which is the malicious manipulation of benign photos or videos to target victims online, including children. Artificial intelligence (AI) is being used to create pornographic images of individuals without their knowledge or consent.

While the unauthorized dissemination of an intimate image is unlawful in Pennsylvania, it is far from clear whether the use of new technology to disseminate an Al-generated, deepfake intimate image of a non-consenting person is prohibited.

House Bill 1063 would make it clear that the use of deepfake technology to create pornographic images without another person's consent is against the law. It would also prohibit the use of deepfake technology to create child pornography.

Such an offense would be a first-degree misdemeanor when the individual depicted is a minor, and a second-degree misdemeanor when the victim is an adult.

HELPING OUR COMMUNITY

Property Tax and Rent Rebate Program Expanded

Legislation I supported that makes more older residents and people with disabilities in Pennsylvania eligible for property tax or rent relief was signed into law by the governor in August.

Act 7 of 2023 increases income limits for the Property Tax and Rent Rebate Program for homeowners and renters to \$45,000. The new law also raises the maximum amount each homeowner or renter can receive from \$650 to \$1,000. The change will take place for those who apply for the rebate in 2024.

The measure expands the reach of property tax and rent relief to nearly 175,000 additional individuals, including about 4,500 Lehigh County residents, and helps to make the Commonwealth a more affordable place in which to live.

The rebate program benefits eligible Pennsylvania residents age 65 and older; widows and widowers age 50 and older; and people with disabilities age 18 and older.

While the new law certainly helps to lessen the tax burden for many, I believe there is still much more work to do regarding the property tax issue. I have been a strong advocate for property tax reform proposals and voted in favor of those that came before me for consideration in the past. I am hopeful additional proposals will be brought before the full House for consideration.

Helping Others by Recycling Old Eyeglasses

STRENGTHENING EDUCATION

Establishing a Civics Education Graduation Requirement

I have introduced legislation that would require Pennsylvania students to receive at least a 60% on the civics test currently administered as a graduation requirement. Currently, students are not required to receive a passing grade and a 60% passing grade is the same threshold used for individuals attempting to become U.S. citizens.

The Pennsylvania Public School Code requires all school entities to administer a test of U.S. history, government, and civics at least once to students during grades 7-12. Students would be eligible to take the test as many times as necessary to attain a passing grade.

House Bill 1720 would also require the U.S. Citizenship and Immigration Services exam be used to satisfy the requirements under current law. Test questions, study guides, and practice tests are all free and accessible on the agency's website.

A 2023 survey conducted by the University of Pennsylvania indicates why such a graduation requirement is needed. The study found that "although two-thirds of American citizens (66%) can name all three branches of government, 10% can name two, 7% can name only one, and 17% cannot name any."

District Office Internships Available

We offer an internship program for college students interested in learning about career opportunities available in state government. The program is reserved for students currently enrolled for credit through an educational institution and is based out of my district offices.

The intern's responsibilities may include, conducting research for possible legislation; drafting correspondence and responding to constituent inquiries; planning an event that is beneficial to the intern and community; and attending events around the 187th Legislative District.

DISPOSING OF FLAGS PROPERLY AND WITH RESPECT

My district offices in Lower Macungie Township and Northwestern Lehigh also serve as drop-off locations for disposing of old or unused American flags. Boxes are available in the office lobbies for residents to place the flags, which will then be retired "in a respectful manner," as stated in the U.S. Flag Code. The code suggests several disposal methods. A flag can be taken to a community disposal box like the ones at my district offices. The flag will then be handed over to the proper group, which will conduct a respectful ceremony to retire the flag. Other disposal options include a burning ceremony, burial in a dignified wooden box, or recycling. Some flag companies will accept old flags and use the material to make new ones.

VETERANS ASSISTANCE APPOINTMENTS AVAILABLE

We offer outreach and assistance to area veterans and their dependents monthly at my district offices in partnership with the American Legion.
